STEP 1

IT IS THE RIDERS RESPONSIBILITY TO DETERMINE WHAT THE SAFE LIMIT IS BASED ON THE POSITION OF THE BAG, PROPER SECURING OF THE BAG AND WEIGHT LIMITS CALLED OUT BY THE MANUFACTURER.

- Reflective outer panels aid nighttime visibility for trailing motorists
- Soft tie-downs (4) for secure four-point mounting on motorcycle passenger seats or other vehicles (Premium Mounting Strap Kit, P/N 5163, sold separately)

BEFORE USE ON A MOTORCYCLE

Make sure your pet tolerates confinement in pet carrier. Pet must be completely inside pet carrier and all access of entry points must be fully zipped closed while motorcycle is moving. If pet has any part of its body outside pet carrier while motorcycle is moving, you and/or your pet could be seriously injured or killed should pet fall or jump from carrier. An adjustable leash is provided to attach pet's collar to D-ring inside carrier. Attachment of the leash does not prevent or lessen the likelihood of injury or death if used while the motorcycle is moving. It is very important that you adjust the leash to minimize pet's movement, to avoid entanglement and to prevent pet from jumping from the pet carrier. If proper adjustment is not made and the leash is too long, the pet may jump or fall out of bag resulting in serious injury or death to the pet.

A CAUTION

AVOID SUFFOCATION BY ALWAYS LEAVING AT LEAST ONE MESH WINDOW COVERING PARTIALLY UNZIPPED TO ALLOW VENTILATION AND FRESH AIR IN THROUGH THE ZIPPED MESH WINDOW. NEVER LEAVE THE PET UNATTENDED IN THE CARRIER.

MOUNTING SUGGESTIONS FOR A MOTORCYCLE

We recommend when mounting this bag on a motorcycle, it is placed on a passenger seat that is supported by a tour trunk. This bag should not be mounted on a trunk rack or luggage rack.

When mounting the Pet Palace Ruff-Pack to the passenger seat, Kuryakyn recommends the bag to be laid down on the seat with the backpack strap side on the seat and the pet door facing towards the rider's back. It is recommended to secure the bag to the passenger footpeg mounts (if mounts are stationary), backrests and/or the frame with the Adjustable Straps with Clips (SOLD SEPARATELY, SEE KURYAKYN.COM FOR MORE **DETAILS**). Be sure the mounting straps DO NOT interfere with the safe operation of your motorcycle. DO NOT secure the Pet Palace Ruff-Pack to the swingarm or any other part that moves independently from the seat. Secure the bag by hooking the straps to the soft tie down loops (PIC 4 AND 5) located on the top back side and the bottom front side. The bag must be secured in all four corners.
